Description of Change

We are opening up a new 66,000 ft² state of the art manufacturing facility in nearby McCook, IL (2.7 miles from our current facility) to produce higher level assemblies. The quality systems (including the work instructions, control plans, quality database, etc.) equipment, manufacturing engineers, technicians, supervisors and operators will be the same as are used to build the products today.

For equipment being transferred, our Quality Control group will be performing installation qualification (IQ), operational qualification (OQ) and performance qualification (PQ).

For product being transferred, our Quality Control group will conduct a level 2 PPAP on representative samples of each product series.

<u>Reason for Change</u>: Production capacity expansion as a result of revenue growth.

Effective Date: The change will be effective on August 31, 2015 for the 3J Series products.
